Convene Finance and Facilities Committee

Trustee Hendrix convened the Finance and Facilities Committee at 3:35 p.m.

Action Item

1. Recommendation on Tuition and Fees for FY 2014 – Brett Dalton presented the recommendation for approval. The administration requested a 3% increase in tuition for in-state students and for out-of-state students, and a 4% increase in tuition for graduate students. The administration also requested a 3 % average increase in room and board.

Trustee McKissick moved to approve the Administration's recommendation related to tuition for FY2014. Trustee Smith seconded the motion. The motion was approved unanimously.

Trustee Hendrix adjourned the Finance and Facilities Committee at 3:47 p.m.
