Teaching Experience

- Lecturer (Clemson University): Introduction to Human Communication, (2012-present). Responsible for lecturing to 250 students as well as teaching up to four lab sections associated with the lecture. Labs include activities, speeches, and discussions while lectures focus on imparting a variety of information on the several different types of communication people encounter every day. Duties include preparing four lessons a week for class, grading, classroom management, speech critiquing, advising, and helping newer students to integrate into University life and classes.
 - O Public Speaking (2013-2015). Responsible for lecturing to a class of 15-20 students, including some sections that were part of an early success initiative incoming freshmen. This situation involved more personal contact with students than the lecture/lab format, which allowed students to receive more individualized help.
 - O Public Speaking, Internet-Hybrid Class (2013, 2015). Similar responsibilities as Introduction to Human Communication in an online setting, with more focus specifically on public speaking techniques. Class would meet once a week for speeches and some lecturing of material. Course assignments and discussions were conducted via BlackBoard academic software.

- **Instructor (Ball State University)**: Basic Communication Course, (2009-2012). Responsible for teaching three sections, 20 students per section. Duties include preparing two lessons a week for class, answering student questions, leading discussions, presenting activities, grading students' written and oral work, and meeting with students for extra help during office hours.
- **Guest Lecturer (Ball State University):** Basic Communication Large Lecture Course, "Public Speaking in Group Situations," (2011-2012). Lectured 3 sections over the course of one day, approximately 400 students per section. This included the preparation of a large lecture that addressed the overall content from a week of study in smaller lab sections, as well as the presentation of material to a large audience.
- Teaching Assistant and Lecturer (Ball State University): Persuasion, "Social Judgment Theory and Balance Theory," "Nonverbal Deception Detection," "Persuasion and the Internet," (2009-2010) Periodically lectured 1 section, 70-100 students per semester. Duties included preparing lectures to cover content as detailed by the professor of the class. Lectures included presenting theoretical concepts relevant to the class, special topics in persuasion, and a weekly discussion on persuasion in the current media.
 - Teaching assistant for professor. Duties included engaging the class in a discussion of persuasion in the news and media once a week, taking notes for students that provided excused absences, grading essay exams, and performing clerical duties for the maintenance and organization of the class
