Requirements:

United States (US) Universities are required by law to verify that students entering the US with temporary student visas have adequate financial resources to meet the expenses of their program of study. You must complete this form in order to receive a Certificate of Eligibility (Form I-20 or DS-2019) from Clemson University (CU), which you will use to apply for your US student visa. All signatures and documentation provided must be originals and must be less than six months old. Support may come from any combination of sources, including personal, family, or sponsored funds. Be sure to provide documentation for each source of funding. If you have more than one sponsor, print or copy this form as many times as necessary and then upload all documents to the portal.

Part III. Funding Sources

You will need to prepare sufficient financial support for the entire period of study.
