Article Indexes & Databases

Although ERIC is the major database for education research, there are several other sources that are primarily used to locate articles in law reviews and other legal publications.

Start from the Libraries home page: <http://www.lib.clemson.edu>. Select "Research by Subject" then click on the subject listing for "Education."

ERIC

Standard index to journals and publications in the field of Education.

Lexis/Nexis

Includes legal news, law reviews, cases, codes, plus full-text of newspapers and magazines.

Legal Trac

Search to find articles in all major law reviews, law journals, specialty law and bar association journals and legal newspapers.

Hein Online

Database of full-text legal resources, including articles, books, codes, decisions, treaties, etc.

Wrightslaw (<http://www.wrightslaw.com>)

Internet resource provides information about special education law, education law, and advocacy for children with disabilities. Includes articles, cases, and resources.
