## The Congressional Record

The *Congressional Record* is the official publication covering the proceedings of the Senate and the House of Representatives. The daily *Congressional Record* contains floor proceedings, extensions of remarks, and a daily digest. The 1st issue of each month includes a summary of bills enacted, bills reported, votes, vetoes, and executive nominations. Later, a permanent edition is printed, with a cumulated Index and a cumulated Daily Digest section.

#### **Senate and House Journals**

From the opening session, the United States House of Representatives and the United States Senate have kept separate journals of their proceedings. The Journal should be seen as the minutes of floor action. It notes the matters considered by the House and the votes and other actions taken. It does not record the actual debates. For those the user must turn to the Congressional Record, and for historical issues, the Annals of Congress, Register of Debates, and The Congressional Globe.

In addition to its legislative journal, the Senate has maintained from its first session a separate record of its executive proceedings, those relating to its functions of confirming presidential nominees and consenting to the making of treaties. The Senate Executive Journal was made public in 1828, when they decided to publish the proceedings for all the previous congresses and in future to publish the journal for each session at its close. Each volume contains an index for that session.

# **The Congressional Serial Set**

Beginning in 1789, the Serial Set is a sequentially numbered compilation of bound House and Senate Reports and Documents. These publications are first issued individually throughout each Congress and are later permanently bound into the numbered volumes of the Serial Set

# **Congressional Commission and Committee Publications**

#### **Introduction of Legislation**

**Bills** (cited as or S. <no.> or H.R. <no.>)

Only a member of Congress can introduce legislation. The term "bill" is used for most proposals, and they can originate in either the House or the Senate. Bills are assigned a number in the order in which they are introduced during the 2-year congressional term.

#### **Joint Resolutions** (cited as S.J. Res. <no.> or H.J. Res. <no.>)

Joint Resolutions were once used to introduce legislation of a general nature but are now used to propose minor, incidental, or unusual legislation or to propose amendments to the constitution. These joint resolutions are also assigned a sequential number, and the language is "resolved" rather than "be it enacted" (which is used for Bills).

#### **Concurrent Resolutions** (cited as S.Con.Res. <no.> or S.Con.Res. <no>)

Although called concurrent, these resolutions do not necessarily go through both houses at the same time. They are usually used to express an opinion, and are not normally legislative in nature. These are also numbered sequentially based on the ordered they were introduced.

### **Resolutions** (cited as S.Res <no.> or H.Res. <no.>)

These resolutions, also called simple resolutions, are used by one house to deal with issues only affecting that body, or to give the sense of the body on a particular issue. Resolutions are also numbered sequentially.

## **Committee Action**

## Hearings

After a bill is introduced, it is assigned to a committee (standing committees each have jurisdiction over bills in certain areas) by the Speaker of the House so that it can be studied. The standing committee (or often a subcommittee) studies the bill and hears testimony from experts and people interested in the bill. Cooper Library receives many of these publications from the Federal Depository Library Program (FDLP) in paper, microfiche, and electronic formats. The numbers for hearings begin with SuDoc number Y 4:, and they are filed in a slightly different way than other federal documents. See the last page of this handout for details.

## **Committee Reports**

If the committee votes to report the bill favorably to the House, one of the committee members writes the committee report. The report describes the purpose and scope of the bill and the reasons for its recommended approval. Generally, a section-by-section analysis is set forth explaining precisely what each section is intended to accomplish. Cooper Library receives many of these publications in paper, microfiche, and electronic formats. When the bill has been agreed to in identical form by both bodies—either: (1) without amendment by the Senate; (2) by House concurrence in Senate amendments; (3) by Senate concurrence in House amendments; or (4) by agreement in both bodies to the conference report—a copy of the bill is enrolled for presentation to the President.



# **Congressional Publications**

The numbers for congressional commission and committee publications (beginning with Y 3. Or Y 4.) use a slightly different format than other federal documents. The set of characters listed after the Y 3. or Y 4. is a committee designation, which is composed of letters and numbers. The letters are based on an important word in the name of the commission or committee. Within the Y section, these documents will be shelved alphabetically, and then numerically by the designation number.

These numbers are often followed by a slash and then a number or numbers. The additional numbers with no dash come before the same number with a dash (followed by another number) thus adhering to the general principle that **nothing comes before something** in Su Doc numbers.

After the colon, several types of individual book numbers are used: dates, numbers, volumes, and Cutter numbers. When used after a colon, a Cutter number is taken from an important word in the title of the document. Usually, for each class number, only one type of book number will be used. However, if both letters and numbers are used for the same class number, the lettered publications are shelved before the numbered ones (letters before numbers).

A slash, and then another number or series of numbers often follows cutter numbers after the colon. Often one of these following numbers is the date of a certain edition of the document. Dates before the 21<sup>st</sup> century appear without the initial 1, ex.879=1879 and 989=1989. **Dates after a slash are shelved before numbers after a slash**.
