### **Scope and Content**

This series contains issuances generated by the Office of the Commandant. The material in the collection covers the period 1927-1952, with most of the collection dating from 1940-1946.

Official bulletins, memorandums, and orders comprise the bulk of the series. Major correspondents include Commandants Herbert Marshall Pool and William Alexander Cunningham.

- Bulletins and Memorandums--Daily announcements issued by the Commandant of Cadets relating to cadets and the operations of the Corps of Cadets. Subject matter includes encampments, formations, drills, and instruction, guard duty, inspections, uniforms and supply requirements, rules and regulations, privileges, and personnel actions affecting individual cadets.
- General Orders -- Announcements of interest to all or to a large group of cadets and faculty. They concern military and academic schedules, regulations, military and academic ranking, special events.
- Special Orders -- Relate to individual officers and cadets and cover such matters as appointments, assignments, promotions, punishments, transfers, and leaves of absence.

The folders are arranged alphabetically by title and chronologically within each folder.

## **Administrative History**

Commandants\*

1894 - 1896

Military Science was established as an integral part of the academic curriculum of Clemson University beginning in 1893 with the institution's first full time academic year of operation.

The following extracts from the Regulations for the Government of Cadets explain the organization and mode of government of the corps.

- "1. The President of the College shall have the general command and government of the institution, watching over its administration, discipline and instruction."
- "2. The Commandant of Cadets, under the President of the College, has immediate command and control of the Corps of Cadets in all that pertains to its organization, drill, military police, discipline and administration. He is charged with the instruction of the cadets in the theoretical military course and in all practical military exercises. He will prescribe the order in which the furniture, bedding, books, clothing, equipments, etc., shall be arranged throughout the barracks, and shall, in person, make a minute and thorough inspection of the rooms, furniture, arms and accoutrements, etc., of the cadets at least once each week, and make a report hereon to the President."

Under the provisions of the National Defense Act of June 3, 1916, the War Department established at Clemson College an Infantry unit of the Reserve Officers' Training Corps (ROTC).

In 1955, the trustees of Clemson College took steps toward becoming a full university resulting in the Corps of Cadets being abolished. The ROTC basic program remained mandatory for only freshmen and sophomore males until 1969. For those students who matriculated initially at Clemson after the spring semester 1970, ROTC was no longer a requirement for graduation.
