Discusses his social life with Hipp, Vogel, and Agnew; Hipp's first marriage; Hipp did things secretly for people they never knew about, yet

he was close with his money and paid low salaries. Asked what he thought Hipp would have done with company had he lived, McDonald replied, "I don't think he could have taken it as far as Francis has." **Clint E. Edwards** – circa 1980

Edwards started as an actuary with J. K. Davis in 1964; says Davis was Actuary for both Southeastern and Liberty until after WWII; Lucian Lee was hired about 1949, John Sloan and Bill Morrow joined later. Discusses insurance, mainly the differences between ordinary and debit sales; the process of writing new insurance policies; changed the old rating system based on skin color to one based on socioeconomic circumstances; and other insurance changes due to the times.

#### 17 A Broadcasting Museum, Charleston Patsy Hicken

Conversation with Hicken, Director of the Broadcasting Museum of Charleston, concerning biographies of Louis Burke and Fred Jordan. End. **W.W. McEachearn** 

A short conversation with McEachearn, President of South Carolina National Bank, about the bank holding company and his membership on the Liberty Life Board of Directors. Interrupted by another interview with Len Maxwell.

## **Leonard A. Maxwell** – circa 1979

This is an additional conversation with Maxwell concerning his advertising and public relations work with Liberty.

## B **R.E. McDonald** – circa 1979

This is an earlier interview with McDonald about work he did for W. Frank Hipp during the Depression, i.e., he picked up cash receipts from around South Carolina, delivering about \$1,000 cash to Hipp every Saturday. W. Frank then put the cash in a wall safe. This was how Hipp had cash on-hand during the Depression. End. Short conversation with **Martha Rivers**, while waiting to interview **John Rivers**.

## Walter Harper – circa 1979

Harper's recruitment as Director of the Board and his relationship with Ernest Hollings, Francis Hipp, James Self, and others; was head of the North Carolina State Commerce and Industry Division when recruited by Hollings and Hipp, and as a well-known, professional leader it was hoped he could generate and develop business activity for the state; was with the Board for seven and a half years – June, 1959 to January, 1967; discusses Hipp's vital role on the board and with Liberty, a key figure.

## 18 A Macon G. "Mack" Patton – circa 1980

Patton started working for Liberty on April 1, 1975. At the time of the interview he had been only with Liberty for five years. Discusses business activities of The Liberty Corporation, including insurance sales, radio and television broadcasting, and savings and loan; the purpose of life insurance speculating on the future of insurance as a product; broadcasting

and increased investment costs; competition in the industry; family ownership and the balance between family and public interests; and the dramatic growth of the company since 1943 - \$500,000 to several billion.

## B Mack Patton – continues

Discusses the future of the company; the ownership base within the Hipp family; and aspects of the corporation's history and growth.
