Advisory Board News



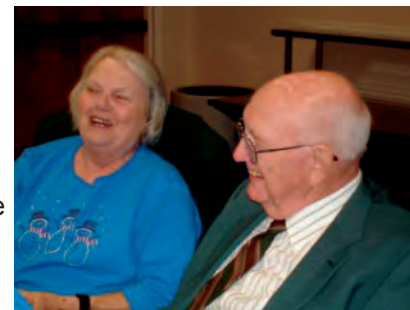
Faculty Senate President Bill Bowerman addressed the winter board meeting and spoke briefly about the work of the Senate. He encouraged the board to continue a close association with the Senate. Emeritus Gary Powell presented the report of the Policy Committee on parking and it was unanimously accepted. The

report will flow through the Senate Welfare Committee to the University Parking Committee. Briefly, the report states that parking decals should be made available, by request, to all emeriti who are not currently on the university pay roll.

In other board business, a membership application for Dr. Paul Adams was accepted and there was discussion about increasing funding for the Emeritus College Scholarship and/or contributing to the student emergency fund. 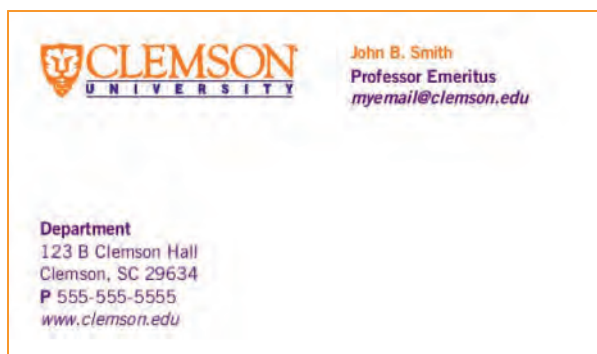

Woodland Cemetery Policies

The Clemson University Board of Trustees recently approved amendments to the Woodland Cemetery Policies and Procedures. The revised document may be viewed at: http://www.clemson.edu/administration/bot/Policies/Woodland_Cemetery.html. Please note the new Policies and Procedures supersede any prior document. Please contact the Board of Trustees Office at 864-656-5615 if you have any questions.



The privileges of the cemetery are extended to eligible full-time University employees and their spouses and to eligible retired University employees and their spouses. To be eligible, an employee or retiree must have been in continuous service with the University for a minimum of 20 years. Full-time status is defined in the University Personnel Manual. Only an eligible employee may reserve a plot; an employee's spouse is eligible only if the employee reserves space for the spouse.

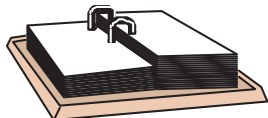
