Executive Summary

The Richland County Stormwater Consortium has reached the 5 year mark! 2012-2013 was another successful year with a wide variety of programming provided to reach diverse audiences about critical pollutants in Richland County streams, rivers and lakes. RCSC partners worked hard in 2012-2013, guided by the Three-Year Stormwater Education and Involvement Strategic Plan developed in 2012.


In 2012-2013, RCSC's public involvement activities gained strength and popularity. Participation in volunteer litter cleanups and household hazardous waste collections grew greatly over the previous year. Local schools also did their part, with fifteen schools installing rain barrels for hands-on learning as well as stormwater control.

The use of online media was also improved this past year. The Carolina Clear website received a face-lift, and Facebook pages, Twitter feeds, a web-based fact sheet series, and a new monthly e-newsletter were all part of RCSC's online efforts this year.

Commercial and residential landscaping, and the associated pollutants nutrients and pesticides, were a priority this year. Outreach to commercial landscapers included workshops, trainings and bilingual outreach materials, to effectively reach both supervisors and crews. For home gardeners, a four part Backyard Landscaping series was held, stressing environmentally friendly principles from RCSC's Carolina Yards program.

A new effort was begun to reduce the top priority pollutant fecal bacteria. A major source of fecal bacteria in Richland County is sanitary sewer overflows (SSOs), which are difficult to impact with education because the public has limited control over sewer systems. Discussions with sanitary sewer providers revealed that disposal of cooking oil and grease down drains is a frequent cause of SSOs, and citizens often don't recognize the necessity or lack the information needed to promptly report SSOs when they occur. Discussions were held to determine ways to educate the public on these issues, and the ideas generated will be implemented in the upcoming year.

Looking forward to 2013-2014, an important goal for the upcoming year is to partner with builders and developers to use Low Impact Development practices including bioretention, pervious pavement and rainwater harvesting. As Richland County grows, developers can make a difference by providing for growth that is sustainable, economically valuable, and protects water quality. RCSC will continue to reach out to all citizens and businesses in as many ways as it can to involve them in efforts that protect local rivers and streams.

Another exciting year for the Richland County Stormwater Consortium! We are continuing to spread the word about stormwater and its relationship to water and life quality. Our programs are becoming more and more focused on source reduction and long term stormwater solutions which will *improve water quality as well* as enhance access and water resource amenities. We are looking forward to the coming *year of stormwater education* and outreach programs.



Year 5 Highlights

- The number of volunteers participating in litter cleanups increased by 50% over the previous year, removing over 102,800 pounds of trash and debris from Richland County rivers, streams, lakes, and ditches (p. 22-23).
- Richland County assisted teachers in installing rain barrels at fifteen public and private schools throughout the county, as part of ongoing Green Steps School projects, school gardens and outdoor classrooms (p. 25-26).
- At 4-H₂O summer day camps, 39 students studied water quality and enjoyed swimming, hiking, canoeing, and exploring Lake Murray and the rivers, streams, and wetlands of Richland and Lexington Counties (p. 17).
- The third annual Summer Celebration of Water family festival brought over 1200 people together to kayak, slide, splash and learn why our rivers and lakes matter to the Midlands and what residents can do to protect them (p. 13).
- The Carolina Yards Backyard Landscaping four-part speaker series brought homeowners together to learn about environmentally friendly gardening principles (p. 20).
- The Watershed Moments e-newsletter was launched in January, and reaches over 100 people each month with news and information about protecting Richland County Waterways (p. 6).

All Richland Countywide Stormwater Consortium partners maintain websites and Facebook pages to share information widely over the internet. The Carolina Clear website now has an updated look for easier navigation and visual appeal. Daily Facebook posts keep audiences engaged and provide a forum for discussion and feedback. TELEVISION: Richland County is in the process of developing a series of television public service announcements on water quality topics, including littering, yard care, pet waste, and construction runoff. RADIO: Richland Radio is a weekly program on WGCV 620 AM that shares news, events, and topics of interest with Richland County citizens. Stormwater staff use this program to promote upcoming stormwater events and programs, such as Summer Celebration of Water and the Carolina Yards program.

On a statewide level, Clemson University's Your Day radio program covers a wide range of topics for the public. Six segments throughout the year focused on water quality. Topics included pet waste, fertilizer, rain barrels, rain gardens, shorelines and other water quality issues.

Commercial landscapers are an audience that can be hard to target because a large percentage of staff may not speak English as a first language. A common issue with landscapers is that they may blow leaves and grass clippings into storm drains, causing clogs and adding nitrogen and phosphorous to the water as the debris decays. To help this audience understand the issue, a door hanger style handout was created in both English and Spanish. This handout

was distributed by Richland County Stormwater staff as part of pesticide, herbicide and fertilizer inspections.

Pet waste tri-fold brochures, distributed through veterinary offices, pet supply stores, and Richland County Animal Care continue to be an important component in efforts to reduce fecal bacteria. The pet waste brochure got an updated look this year to make it more eye-catching. Additionally, promotional items, brochures and handouts on a wide range of topics were distributed at fairs, festivals, and events throughout the year.

The Congaree Riverkeeper works to protect and improve water quality, wildlife habitat, and recreation on the Congaree, Lower Saluda and Lower Broad Rivers through advocacy, education and enforcement of environmental laws. These rivers are vital to the Midlands, bringing in fishing, boating and outdoor enthusiasts and building tourism. The Riverkeeper uses social media, festivals and other events to engage the public and build a dialog about the importance

of protecting our natural resources. They work closely with the on-the-water recreation community to give them a voice and help them interface with local leaders about current issues important to water quality in the rivers. They also organized several cleanups throughout the year, conduct quarterly monitoring at seven sites in the Congaree River watershed, and are frequently in the local media for their advocacy efforts.

The Rocky Branch Watershed is an urban watershed flowing through the City of Columbia, and includes Five Points, Maxcy Gregg

Park, University of South Carolina campus, and the Olympia neighborhood. The Rocky Branch Watershed Alliance was formed by Sustainable Midlands in December of 2011 to unite citizens in improving water quality, reducing flooding, and restoring the beauty of this urban stream. Heavy flooding in Five Points and Olympia is a key issue driving citizen involvement, as is planning for development in a way that protects the floodway. The Rocky Branch Watershed Alliance holds public meetings, meets with local leaders, organized cleanups, has displays at festivals, and uses other outreach methods to engage the public and local decision makers on protecting this urban watershed.


Festivals and fairs offer great opportunities to reach a large number of people at one time. General events such as Sparkleberry Fair, attract a broad audience that may know little about environmental protection, while environmentally themed events, such as Party for the Planet, attract audiences already tuned into green issues and eager to learn more ways to make a difference. By drawing visitors with colorful displays and hands-on activities, such as the Enviroscape watershed model or live pond creatures, RCSC can build general awareness and provide detailed information on specific issues. Handouts and giveaways (see p. 7) remind visitors of what they learned after the event is over and can serve as prompts for behavior change. The third annual Summer Celebration of Water was held on August 6th at Riverfront Park in Columbia. To increase the variety of in-school presentations, Carolina Clear introduced a new macroinvertebrate lesson for elementary schools. Our newest education partner, Congaree National Park, coordinates a program for third graders titled Linking Ecology and Art of Floodplains, which reaches over 1,000 students and over 50 teachers each fall. The Enviroscape watershed model continues to be a go-to activity for after school groups, scouts, and summer programs.

Students at Dent Middle School participated for the first time this year in the Future City Competition, which challenges students to design cities of the future around a particular civic issue. The issue for the 2013 competition was stormwater, so the school turned to RCSC partners for help. Carolina Clear, Gills Creek Watershed Association, Richland County Stormwater staff, and others mentored students on managing water quality and quantity in an urban landscape. Richland County Council and county staff make many decisions that impact how stormwater is managed, both for quantity and quality concerns. Flooding is a problem in many parts of the county, and Richland County has a number of waterways that are impaired (or not suitable for fishing and recreation) because of bacteria and other pollutants. Helping county leadership to understand the technical aspects of the concerns presented to them by citizens, and their options for resolving them, is vital to their decision-making process.

During the past year, Richland County developed an Open Space Ordinance, which replaces the Green Code. This ordinance provides incentives for developers that want to use Low Impact Development (LID) practices in new construction projects. These LID practices might include bioretention, pervious



pavement, rainwater harvesting, green streets, etc. To qualify for incentives, the developments must also include preservation of natural and open spaces and stream buffers. In the upcoming year, RCSC will work to further engage the development community in the use of LID techniques and open space development to improve water quality in Richland County.

RCSC has several ongoing initiatives for businesses. Partners for Healthy Watersheds is a recognition program for businesses that want to show that they are doing their part for clean water. Presentations for local chambers of commerce and a display at the Green is Good for Business Conference were used to build awareness off the program. Next year, new incentives will be added and new contacts made to increase participation in this program.

To reach out to the local faith community, Sustainable Midlands offered a Caring for Creation workshop as part of its ongoing Green Congregations Initiative. Places of worship, like any other business or facility, can take steps to protect the environment and make a difference through their practices.

With the help of the Central Midlands Council of Governments, RCSC has worked with local sewer service providers to brainstorm ways to reach customers with information about reducing fats, oils, and grease (FOGs) in drains, as well as reporting sanitary sewer overflows. New materials will be developed in the next year to communicate more effectively with the public and help them do their part in reducing sanitary sewer overflows.

A series of outreach initiatives were offered specifically for landscaping, horticulture and agriculture businesses. These audiences can have a direct connection with water quality. Misuse of herbicides and pesticides can introduce toxic contaminants into rivers and streams, and overuse of fertilizer can lead to algae blooms, low dissolved oxygen and fish kills. Overuse of irrigation can cause erosion and other issues related to water quantity.

Through its new Organic Richland program, the Richland Soil and Water Conservation District held workshops on Integrated Pest Management and Irrigation and Water Management. The workshops included speakers from USDA-NRCS, Clemson University, and Clemson Extension.

The Richland County Stormwater Department held a Pesticide, Herbicide and Fertilizer conference with speakers from Clemson University's Department of Pesticide Regulation (DPR). This training focused on safe storage and handling of PHFs, covering the issues and violations most commonly encountered by DPR staff. Richland County stormwater staff also conducts PHF inspections throughout the county. The conference was an important addition to the outreach stormwater staff do during their inspections, giving them an opportunity for clarification and details. Richland County inspectors also distributed a new handout on yard waste, printed in both English and Spanish, during their visits to businesses throughout the county (see p. 7).

Litter Sweeps

Litter is a highly visible problem with serious consequences for streams. Electronic waste, plastics, tires, and other materials can release harmful chemicals as they break down and may be mistaken for food by wildlife. If citizens perceive a stream as already polluted, they may not try as hard to keep it clean. On the other hand, litter cleanups often serve as a first step for getting citizens involved in their watershed. Litter is easier to see and understand than other pollutants, and may inspire a community to take action. Participating in cleanups offers instant gratification from the improvements made, and leave citizens feeling empowered to make a difference.

A two-day water monitoring workshop was held May 15 - 16 at Congaree National Park, coordinated by staff from the Old Growth Bottomland Forest Research and Education Center, Region IV EPA, and SC Department of Health and Environmental Control. Participants learned how to conduct basic stream health evaluations using simple monitoring techniques. These included sampling for and identifying macroinvertebrates, assessing types of stream habitats, and understanding stream flow and hydrology. Long term, Congaree National Park hopes to assist citizens in establishing consistent water quality monitoring programs in South Carolina.


Over the past year, fifteen public and private schools throughout the county installed rain barrels as part of ongoing Green Steps School projects, school gardens or outdoor classrooms. Not only do the barrels provide opportunities for hands-on learning at the school, they serve as demonstrations of stormwater management techniques that can be implemented by the families of the students at their own homes. Other school projects related to water quality included an erosion control installation and improvements to a school rain garden.



Year 5, 2012-2013


Other than the general public, in terms of direct outreach, youth was the target audience reached in greatest numbers in Year 5. Classroom presentations, activities at children's events and rain barrel installations at schools reached more youth than in any previous year. Professional audiences were the next highest group reached, through increased CEPSCI and CSPR trainings and the South Carolina Water Resources Conference. Commercial audiences were also reached in high numbers, with special focus given to landscaping professionals.

In Year 6, RCSC plans to increase outreach to the development community by building partnerships with developers, contractors and builders. In July of 2013, Richland County passed an Open Space Ordinance that provides incentives for developers using Low Impact Development (LID) principles. RCSC will work with the Home Builders Association of Greater Columbia to determine what education is needed by builders and designers to put these principles into practice, and create a strategy for providing outreach to encourage the use of LID in the Midlands. These programs will also attempt to bring elected and appointed officials into the conversation to make sure regulations allow good

opportunities for implementing LID.

Debris was the most effectively targeted pollutant in 2012-2013, due to increased interest in volunteer litter cleanups and recycling events. Impacts focusing on toxic contaminants were second, and nutrients were third. Toxic contaminants were addressed through recycling events for household hazardous waste and electronics. Outreach focusing on pesticide, herbicide and fertilizer usage for landscapers and home gardeners addressed both toxic contaminants and nutrients.

In the upcoming year, new outreach materials and websites will be developed to address fecal bacteria contamination resulting from sanitary sewer overflows. This will be done in partnership with sanitary sewer providers across the county. Partnerships with local septic tank service providers will also be investigated as another way to reduce sources of fecal bacteria.

Drawing from the RCSC Three-Year Strategic Plan, county monitoring data, and experience from previous years, RCSC looks to the 2013-2014 programming year with excitement. As our programs grow and evolve over time, we are encouraged by the results we see and look forward to implementing programs and engaging the public to protect water quality in the year ahead.

"This is a greenspace right now which is helping the water quality that is coming into Cary Lake," Erich Miarka, program coordinator for the watershed association, said Monday Miarka and others have met with school officials to make sure they are aware of the fragility of the 70-mile stream system that meanders through Richland County, Arcadia Lakes, the city of Columbia, Fort Jackson and Cayce. Richland 2 has an option on the property just off Decker Boulevard, but has not made a formal purchase, said Fred McDaniel, Richland 2's chief planning officer. The land has been surveyed and the district is doing due diligence on the property. In a meeting, McDaniel said he reassured the environmental and homeowner representatives that the 24-acre plot the district wants to buy will have no negative impact on the watershed. He said another meeting is planned for next week. Richland 2 board member James Manning said Monday he also has met separately with the Cary Lake Homeowners Association, whose members are concerned about the potential for sediment runoff into Cary Lake. "The homeowners association brought up green construction, permeable asphalt versus less permeable asphalt," Manning said. "Some of those things they are looking to have done, we can do.' Manning noted the district already is building to LEED, or Leadership in Energy and Environmental Design, certification, which means some green aspects already are part of the Richland 2 construction culture. Steve Brown, president of the Cary Lake Homeowners Association, said the association's members do not want to place themselves in an adversarial position with the district, which has planned the school to ease population size at some of its nearby elementary schools, including Keels, Forest Lake, Conder and Windsor Lake. "We are not against the building. We just want to follow the rules and regulation which will, in turn, improve the watershed," said Brown, who leads the organization that represents 46 landowners around the lake. "That land area is going to need the Gills Creek watershed drainage system. All we ask is they join us in protecting it. McDaniel said the land contains about 21/2 acres of wetlands, which will require a permit from the U.S. Army Corps of Engineers to proceed. He said when the district approached the property owner about the land, the owner specifically said he did not want to sell the southernmost piece that contained the confluence of Jackson and Little Jackson Creeks. Richland County has envisioned a network of trails and parks that utilize the waterways around that area. "What we are planning to do would have no impact on the trails that they are planning to put in or sedimentation of the lake," he said. McDaniel said the district also would be willing to partner with organizations to establish an

environmental laboratory for students to utilize.

Miarka said the watershed association, a partnership made up of federal, state and local governments as well as local individuals and environmental groups, has "kind of a vested interest" in protecting Cary Lake after taking a role in the county's dredging project of Cary Lake several years ago.

Mark Huguley, vice president of the Cary Lake Homeowners Association, said the cost to the county of dredging what he described as a "stressed urban lake" was between \$700,000 and \$750,000. Add to that monies the county plan to spend to develop trails and restore wetlands around Decker and coordination among government entities is imperative, he said. He worried that such communication wasn't apparent until the civic groups entered the discussion.

"All of us feel good about the school district building in this area — no one is against the school," he said. "We just want the district to be sure to take our concerns into consideration and act appropriately."

Arcadia Lakes town council is preparing to draft a letter to the district expressing its concern that any construction takes into account the fragile watershed and does not add to stormwater runoff, town clerk Christine Murphy said Monday.
