## **Ongoing Projects**

The Twenty-five Mile Creek Watershed planning grant project continues to make progress. Two public hearings were held, the first on April 17<sup>th</sup> at the Elgin Town Hall, and the second on April 18<sup>th</sup> at Kelly Mill Middle School. The final stakeholder meeting was held on June 25<sup>th</sup> at Sandhill REC. Greg Sprouse spoke to Angela Vandelay with AMEC, the consultant on the project, about the June 25<sup>th</sup> meeting and was told the meeting went well as far as planning for the site. The next step in the planning process will be completion of the implementation plan for reducing pollution in the Twenty-Five Mile Creek Watershed. Following this, Kershaw County will apply for a 319 Implementation Grant. The application period for the next round of 319 Implementation funding has not yet been announced. Mary will share any and all details of the final plans as they become available.

### **Year 6 Education Plan of Work Discussion**

#### General Public

Mary began the discussion by distributing a draft of education and outreach programs for the next year. Also distributed was the Three-Year Strategic Plan table of actions. Overall the Consortium is making good progress in the plans. Starting with the general public programs the consortium discussed the different programs proposed for the next year. FOGs were omitted from the Television PSAs activity. Articles in the newspaper were discussed as being a good method of communication with the public about problems in the community. Mary will be writing one or more new H2Ownership factsheets in the upcoming year, and is looking for suggestions for appropriate topics. The subject of storm drain marking was discussed. Bill Stangler proposed undertaking apartment storm drain marking and FOGs campaign. The consortium agreed that the sewage overflow hotline magnets should not be distributed anymore because the number is not helpful (goes to Bree Tribble's voicemail). At present, the calls should be sent to the Ombudsman's office to start the process and then follow up after that to keep the issue from getting delayed (as in Eric Miarka's case of 10 days). Bill Stangler proposed a website that could be used to handle all reports. Mary brought up the point that people still need to be informed in order to find the website. The consortium agreed to brainstorm the matter further for a solution. The Crane Creek Watershed Association was brought up. William Boyd said that this is still a priority for Richland County. Efforts will be renewed to develop the public involvement needed for a watershed group. The difference in demographic as compared to the Gills Creek and Rocky Branch Watersheds makes involvement difficult to achieve. Eric brought up the option of Crane Creek Watershed being a possible 319 grant site. The issue of capital improvement was updated to include a website that tracks and displays completed, in progress, and future projects in this area.

## Youth

For youth audiences, the problem of diversifying the offered programs was addressed. School visits, day camps, and Green Steps Schools projects will continue. At present, Green Steps Schools projects are exclusively rain barrel focused activities, and Chanda Cooper would like to expand these to include other types of projects. In 2013-2014, we will look for opportunities to include new partners and programs for youth. However, it was agreed that this audience is already a demographic that the group knows how to reach.

## **Professionals**

Eric Miarca brought up the Gill Creek ideas for bag lunch talks. The events would be open to the general public with specific invitations going to target professionals in the respective fields of discussion. The specialized topics currently being planned are stormwater BMPs and pond maintenance talks. The talks are set to be held in The Cooper Library main branch. LID was discussed as being closely related to the BMP subject of these lunches. This along with an LID Atlas and publicly visible LID installation site were public outreach mechanism discussed. Suggested options for this installation were a school yard display of some kind, a county park (such as Olympia Park), and a green roof on the Central Midlands building.

# Elected and Appointed Officials

As far as the elected officials activities, brainstorming needs to take place about ways to get political attention for various activities. Greg Sprouse discussed the presentations and demonstration sites planned for COG. The goal of these presentations is to provide the board members with information about the public attention and participation in different activities. The need to schedule a talk about LID and watershed planning (Gills Creek) was also brought up. The Carolina Yards program was discussed as a way to tie in council member participation into the proposed programs.

#### **Homeowners**

The need for exciting promotions for the Carolina Yards program was discussed as only three homeowners are currently enrolled. The FOGs Presentation for HOAs was omitted from the activity chart. However, the need for FOG management for homeowners was discussed as needing to be more understandable and simple. Bill Stangler brought up can lids that make disposal of FOGs easier. The city of Columbia has similar FOGs lids. The idea of having similar lids made and ready for distribution before the Summer Celebration of Water was brought up and approved. The previously discussed Olympia park LID installation was discussed as satisfying the Rocky Branch partnership. Chanda gave information about the OMG program for new homeowners. The workshop series will be looked into as a possible partnership opportunity.

#### **Businesses**

The PHF conference for commercial citizens was discussed as needing to be moved to a fall or winter date due to the seasonal nature of the attendees' businesses. The Partners for Healthy Watersheds Program is a program that promotes better land and runoff management by businesses. Mary has all the information and incentive materials prepared all that is needed for launch is contacts and participating businesses. Woodley's Garden Center and Urban Outfitters were suggested as possible pilot businesses for the program.

### Submitting Annual Report Data

Mary reminded the group that it will soon be time to start submitting data for the Annual Stormwater Education Report. The end of the reporting year is June 10<sup>th</sup>. The report is due to DHEC in August, so it is important to submit data as soon as possible following June 10<sup>th</sup>.
