It was noted that there was a Gills Creek TMDL public hearing at the same time as this meeting, which prevented a number of regular participants from attending. The meeting began with a brief review of recent and upcoming activities:

Mary will continue to meet with Sirinivas and Keith monthly in addition to the consortium meetings.

Next we discussed the Annual Report, due to SCDHEC in September.

- All education partners need to have their activity data submitted to Mary by July 22 at the very latest. Because the RAIDP server has had a number of issues lately, submission by email are acceptable.
- Mary will complete a draft as soon as possible for Srinivas's review, and the final draft with all necessary corrections will be due on August 22 for submission to the printer.
- Three hard copies will be printed by the 27th for final review, giving us two weeks before the final due date to SCDHEC, on Sept. 10.
- 30 copies will be printed for distribution to Richland County Administration, plus extras for general use.
- This year's report will contain a number of graphs, diagrams, and analysis, showing increase in number of programs over last year, audiences reached, pollutants targeted, etc. This will be a tighter, more analytical report, highlighting our progress and continuing improvement.

The remainder of the meeting was spent discussing the remaining portions of the education plan: Homeowners and Businesses. Important notes from the discussion include:

- Shaun Greenwood suggested that rather than mail-outs, use trash can hangers to convey messages. This might be a good way to target hazardous household waste. Forest Acres has had success with this in the past. Because Richland County contracts with two companies to pick up trash, it may be harder for them. Arcadia Lakes has backyard pickup, so trashcan hangers are not an option. A pilot program within Forest Acres might be appropriate to start with.
- The County is installing rain gardens at Owens Field Airport, Killian Park and North Springs Park. These will be installed professionally so a workshop is not an option, but signage can be used to educate visitors to these locations.
- Crayton Middle School might have a spot for a rain garden project. Shaun will speak to the principal, Susan Childs.
- Mary will get in touch with Caroline Hudson who has taken leadership of the Arcadia Lakes Navy to continue education programs through their organization.
- Mary will reach out to Anna Almeida, the new deputy director over the Richland County Planning Department (replacing Joe Kocy?).
