Social Media

Because at least 9 RCSC partners have Facebook pages, with over 3099 fans total, we took some time to discuss social media and how to get more impact from our pages. Mary recently attended a training from Clemson IT specialists on this topic, and shared what she learned.

Ways to get your links shared more

- Include numbers in status titles ("1200 People attended Summer Celebration of Water")
- Posts with certain words get shared more than others: why, most, world, how, health, bill
- Post on weekends
- Write with a positive spin
- Use plain English
- Include videos if possible

Ways to get your page "Liked" more

• Users have to "Like" before they can comment, so anything that inspires comments, such as giveaways, questions, polls.

Ways we can help each other

- "Like" each others pages
- Tag ourselves in pictures on each other's pages
- Re-share posts from each other's pages
- Comment on each other's pictures and posts

Sanitary Sewer overflows

The goals of this program are:

- Promote awareness of the issue
- Encourage public reporting of overflows
- Follow-up with affected communities

Our current outreach strategy for sanitary sewer overflows consists of distributing the Stormwater Hotline magnets and encouraging people to report overflows to the hotline. Some possibilities for new ideas were to develop a TV slide or a brochure related to this topic. Brochures could be distributed at events and given out when responding to reports. Keith informed the group that there are a number of sewer providers within Richland County, not just the city's sewer line. The first step should be to see what materials or initiatives they already have on this topic. Because many of them send a separate sewer bill (not on the water bill), we could have an insert in the bill. This would be cost effective. Keith will provide Mary with a list of sewer providers and their contact information. Mary will follow up with the sewer providers.
