Tools Update:

- Stormwater Hotline magnets finished and distributed
- Year 1 Report complete – don't forget to still report Year 2 activities
- Signs around Richland County – as seen at the County Admin Bldg parking lot – announce to prevent stormwater pollution and call hotline if you want to report a pollution problem

- Overview of the Stormwater Education and Public Involvement Meeting with DHEC's Bureau of Water Personnel (*Please see attached summary for details*)
- Katie Giacalone provided the consortium with a summary of the meeting. The most important points were:
- The regional decision making process: this approach is acceptable, as long as each MS4 participates actively.
- Target Pollutants: General awareness is important, but should not stand alone as a target pollutant. Programs should target specific pollution issues. Pollutants can be targeted for educational programs even if they are not on the 303d list (i.e. sediment) if they are felt to be of concern. Also, some pollutants on the 303d list cannot be effectively addressed through education (such as arsenic) and do not need to be part of the education plan.
- Target Audience: Youth are a critical audience, but not the only one.
- Decision Process Worksheets provided by DHEC may be helpful, but other forms of reporting (like what we produce) are acceptable as long as they clearly show the decision making and implementation processes.

Resolution Signing/Press Event: Tuesday, Oct 6th at 10am at Richland County Administration Bldg, room not yet known.

- Need high resolution logos from everyone for displays and banner
- Everyone is welcome to create displays for the event
- Mary is working on a banner
- Discussion of speaker: currently have Clemson researchers/leaders on hold, but we can invite a local guest speaker who is a-political and is known for their work protecting water resources.
- New location discussed – perhaps under tent at public works building?

Meeting time update: It was brought to the group's attention that Forest Acres has a conflict with the scheduled meeting time of the second Wednesday of each month at 1:00. The consortium members present agreed to change the meeting time to 10:00 on the second Wednesday of each month. This decision will be submitted to the list serve for feedback. It is our goal to make attending consortium meetings as convenient for as many participants as possible, and that participation by the MS4 representatives takes precedent.
