## Partner Update from Arcadia Lakes Navy

Larry Cooke from the Arcadia Lakes Navy gave the group an overview of ALN and its recent and planned projects. The Arcadia Lakes Navy is a concerned citizens group with the goal of identifying and correcting water quality issues in Arcadia Lakes. Its current projects are funded by a grant from the Richland County Conservation Commission. The project budget as approved by the Commission will be used to:

- Mark Storm drains completed
- Rain Garden design/build demonstration in the planning phase

- o The Tree Of Life Congregation will be the location of our Rain Garden Location.
- o The Gills Creek Watershed Association and Carolina Clear are partnering in project also.
- o The Tree Of Life has a underused large detention area that will be converted into a Rain Garden and possibly a rain harvesting project.
- Rain water harvesting demonstration
- National Wildlife Federation Certify Backyard Wildlife Habitat Sites in Arcadia Lakes
- Signage for water quality
- Lake monitoring outreach
- Water Watch Navy
  - Potential problems are being identified and brought to the attention of the property owners, Richland County, and SCDOT when necessary. Two such issues are flooding at Arcadia Springs Circle and a vacant car lot on Two Notch where stormwater is flowing down an asphalt slope through holes in curb and gutter onto neighboring properties.

### Stormwater Roundtable Discussion

- Pam Greenlaw suggested a partnership with Sustainable Midlands which has been involved in the County Stormwater Roundtable.
- On Tuesday Oct. 20, the new stormwater ordinances may go before county council for a third reading.
  The stormwater roundtable has adopted a number of principles on improving water quality and quantity
  issues. They would like the council to adopt the principles as well and rewrite the ordinances accordingly
  instead of completing the third reading.
- Richland County is very interested in planning a Stormwater festival and intends to move forward with this for Summer 2010.
