Human behavior is a risk which is influenced by a variety of factors which exceed the implemented safety controls for inherent risks laboratory environments. Simply stated, human risk factors are residual risks which must be considered when addressing laboratory safety. This presentation will explore the invisible risks within the laboratory – those directly associated with human risk factors or residual risk which exists after inherent risks are controlled for strategically.
