

Besides the security of a fixed income, you may benefit from a charitable income tax deduction and a portion of your annuity payments could be tax-free. Giving a gift that helps further the goals of Clemson while paying you for your generosity is like having your cake and eating it too!

A charitable gift annuity allows you to receive payments immediately.
