² A grade of C or better is required to take MATH 2070.

³ Elective hours may be used for courses not required by General Education or your major curriculum and may be taken in any combination or at any time during your college career.

⁴ See General Education Requirements list in the catalog. If this requirement is met through the completion of another General Education requirement, students will have three additional elective hours. Students must complete 120 total hours. Global Challenges credit hours must be selected from two different fields unless identified as interdisciplinary. At least three credit hours must be selected from a course(s) at the 3000-level or higher. A transfer course may **not** be used to satisfy the General Education Global Challenges Requirement. While a transfer course may fulfill other degree requirements, students must enroll in a Clemson course(s) on the Global Challenges list to fulfill the Global Challenges Requirement.

Notes:

A. **MOST ACCOUNTING & FINANCE COURSES REQUIRE A GRADE OF C OR BETTER.**

B. Financial Management majors are required to have a minimum grade-point average of 2.0 in all Finance (FIN) designated courses to graduate. Only the last grade for courses that are repeated is used in computing this grade-point average.

C. At least 50 percent of the total credits taken in ACCT, ECON, FIN, LAW, MGT, and MKT must be taken at Clemson University.
