SUBJECT: REVENUE-BASED BUDGET STEERING COMMITTEE CHARGE

#### **BACKGROUND**

In 2020, universities braced themselves as a pandemic swept the globe, changing the landscape of higher education. In 2021, determined to power out of COVID and make big advances, Clemson initiated a deep analysis of progress toward aspirational goals and opportunities ahead. The result, ClemsonElevate, delivers bold ideas and strategic priorities that position Clemson to remain a nationally preeminent institution. This plan outlines key enablers necessary to drive efficiency, leverage resources, and add critical infrastructure. The objective of the Revenue-Based Budget (RBB) Steering Committee is to explore a proposed framework for one of these key enablers, the Clemson University budget model.

#### RBB STEERING COMMITTEE CHARGE

Investigate and characterize an ideal revenue-based funding model to support Clemson University's strategic priorities and three mission areas: 1) teaching, 2) research, and 3) outreach. The model should position the institution to further strategic objectives and academic ambitions, create a structure for effective decision-making, and provide agility in response to changes in the landscape of higher ed.

## **APPROXIMATE TIMELINE**

Over the course of a year, the Steering Committee should meet regularly to strategize on core components of a revenue-based budget model for Clemson. Focus should be given to how each component drives incentives.
