

Dropping from Full-Time to Part-Time Adjustment Calculation Examples

Example 1: In-state student registered for 15 credit hours drops 9 credit hours during 80% adjustment	
Original Assessment, full-time, in-state fees*	7,178.00
per credit hour rate**	644.00
<u>Liable hours calculation</u>	
# dropped hours	9.00
Liable percentage (1-.80)	0.20
Liable Hours	1.80
Liable hours X per credit hour rate**	1,159.20
Calculation for remaining registered hours (hourly rate X per credit hour rate)	3,864.00
New Assessment (Liable amount for dropped courses + remaining hours amount)	5,023.20
Adjustment to fees (New Assessment minus Original Assessment)	(2,154.80)

Calculation for remaining registered hours (hourly rate X per credit hour rate)	10,776.00
New Assessment (Liable amount for dropped courses + remaining hours amount)	14,008.80
Adjustment to fees (New Assessment minus Original Assessment)	(6,431.20)

Original Assessment, full-time, in-state fees*	7,178.00
per credit hour rate**	644.00

Liable percentage (1-.60)	0.40
Liable Hours	3.60
Liable hours X per credit hour rate**	2,318.40
Calculation for remaining registered hours (hourly rate X per credit hour rate)	3,864.00
New Assessment (Liable amount for dropped courses + remaining hours amount)	6,182.40
Adjustment to fees (New Assessment minus Original Assessment)	(995.60)
Example 1: Out-of-state student registered for 15 credit hours drops 9 credit hours during 60% adjustment	
Original Assessment, full-time, in-state fees*	20,440.00
per credit hour rate**	1,796.00
<u>Liable hours calculation</u>	
# dropped hours	9.00
Liable percentage (1-.60)	0.40
Liable Hours	3.60
Liable hours X per credit hour rate**	6,465.60
Calculation for remaining registered hours (hourly rate X per credit hour rate)	10,776.00
New Assessment (Liable amount for dropped courses + remaining hours amount)	17,241.60
Adjustment to fees (New Assessment minus Original Assessment)	(3,198.40)

Calculation for remaining registered hours (hourly rate X per credit hour rate)	10,776.00
New Assessment (Liable amount for dropped courses + remaining hours amount)	20,440.00
Adjustment to fees (New Assessment minus Original Assessment)	0.00
