Involvement in similar or additional disciplinary incidents while on probation may be cause for recommendation of immediate suspension or expulsion.

- a. If Kappa Sigma successfully completes three (3) years of this Disciplinary Probation with no further incident, the serving president may petition OCES to remove the final year of Disciplinary Probation. This petition may be submitted directly to OCES at the beginning of the Spring 2028 Semester.
- 2. Effective immediately, Kappa Sigma is on Social Probation until the successful completion of a full Membership Review coordinated, completed, and confirmed by Kappa Sigma Headquarters. Social Probation prohibits Kappa Sigma from hosting, cohosting, or participating as an organization in registered social events with other organizations.
- 3. Kappa Sigma is to comply with and complete all sanctions imposed by Kappa Sigma Headquarters as outlined by Leo Brown, Vice President of External Affairs Kappa Sigma HQ.
 - a. OCES will communicate with Kappa Sigma Headquarters to ensure completion at the appropriate stages of Membership Review, Chapter Review and Goal Setting, Brothers in Action, Chapter Improvement Plan, and all other relevant milestones.

 - ii. Establish/Review membership expectations by Fraternity, chapter and University
 - iii. Conduct chapter strengths and weaknesses assessment.

- iv. Chapter vision and goal setting and identity building.
- v. Development of a recruitment plan and balanced chapter calendar.
- vi. Establish a plan for Phikeia education which aligns with expectations and promotes member development.
- 6. During the Spring 2025 semester, all members will be expected to complete the following ongoing education:
 - a. Bystander Intervention
 - b. Pursuit of Greatness: Personal and Professional Greatness badges.
 - c. All Phikeia education modules
- 7. Chapter Operations and Support
 - a. General Headquarters and Fraternity Volunteers will work to place and train new chapter officers.
 - All officers will be expected to complete their respective officer training modules and Clemson University trainings within 10 days of their appointment. General Headquarters staff and Fraternity volunteers will work with appointed chapter officers to develop internal operations systems including:
 - i. Updated bylaws in alignment with Fraternity expectations
 - ii. Process for member accountability
 - iii. Process for membership selection and membership criteria.
 - c. Chapter leaders will meet with General Headquarters Staff monthly throughout the academic year.
 - d. The chapter will receive on-site support from General Headquarters staff frequently during each the Spring 2025 and Fall 2025 semester.
 - e. The chapter will also receive regular in person support from the Province President (regional volunteer).
 - f. Director of Volunteer Support will work to recruit and train additional chapter advisors to support the chapter at the local level.
- 8. Recruitment
 - a. General Headquarters staff will assist the remaining members in developing a plan for Fall 2025 recruitment, with focus on recruiting men committed to upholding Fraternity values and expectations.
- 9. Phikeia Education

- 3. Surrender balances of all organizational funds granted by Student Government.
- 4. Vacate office or housing space assigned by the University. Space vacated due to suspension may be reassigned to other eligible University organizations. In the case of housing, individual members will be reassigned provided space is available. There will be no University Housing contract cancellations.
- 2. RELATED SANCTION: The suspension of organizational recognition for Alpha Sigma Phi will be for one year which is equal to one calendar year from the date the chapter was placed on interim suspension. Therefore, no earlier than September 10, 2015, the national office of Alpha Sigma Phi may forward a letter of intent to the Office of the Dean of Students expressing interest in re-establishing the formerly suspended student organization. The letter should explain plans that assure appropriate guidance, support, advice, and supervision of the student organization. The letter must also provide documentation of completion of any requirements placed upon the student organization by the University through the student conduct process. The first time that Alpha Sigma Phi will be eligible to accept new members will be through the formal recruitment process of the Interfraternity Council in the spring of 2016.
